The US Equestrian Federation welcomes you in hosting and/or participating in a Lite Licensed competition. The USEF Lite Competition Program was developed as an accessible competition product for organizers who wish to “test drive” hosting a USEF licensed competition. This program provides access to equestrians who are interested in competing under the framework of organized equestrian sport, involving rules and policies that support the safety and welfare of equestrians and their horses and offer a fair and level playing field.

This *How to Guide* will aid in helping you understand what a Lite licensed competition has to offer. Within this guide you will find quick links for information, a reference chart for Lite specific competitions, USEF staff contact information, and more.

# REFERENCE CHART FOR LITE COMPETITION

| MAIN AREAS OF REQUIREMENT            | USEF LITE LICENSE  |

| <b>License Requirements</b>          | <ul style="list-style-type: none"> <li>• Licensee Registration is required before applying for a license. <ul style="list-style-type: none"> <li>◊ Required annually for show management</li> </ul> </li> <li>• License Agreement Applications must be submitted thirty (30) days prior to the event</li> <li>• A show may run with a Lite license if it is: <ul style="list-style-type: none"> <li>◊ a first-time competition</li> <li>◊ if the competition has only run under a Lite license within the past three (3) years</li> <li>◊ or if the competition has not been USEF licensed within the past three (3) years.</li> </ul> </li> <li>• Competitions that do not meet the above requirements may request for an exception which will be reviewed on a case-by-case basis by the CEO. <ul style="list-style-type: none"> <li>◊ To submit an exception, please email your reasoning for the exception to <a href="mailto:clockhart@usef.org">clockhart@usef.org</a></li> </ul> </li> </ul> <p>Competitions may only run under a Lite license for three (3) consecutive years</p> <ul style="list-style-type: none"> <li>• Exception - <u>"A competition that meets the criteria listed on the Federation website." - GR310.7(1)(a)(4) – Horse Entry Thresholds</u></li> </ul> <p>*Note – All previously licensed USEF Lite competitions, prior to 2023, will be considered new USEF Lite competitions and will be able to operate for three (3) consecutive years.*</p> |
| <b>USEF Membership Requirements</b>  | <p>A Competing Membership is only required for athletes seeking HOTY points or those signing the entry blank as the trainer/coach (see below).</p> <ul style="list-style-type: none"> <li>• Owners of horses seeking HOTY points must be competing members and the horse must have a recording.</li> </ul> <p>Trainer or coach must be a Competing Member and sign the entry blank.</p> <ul style="list-style-type: none"> <li>• Youth competing without a trainer or coach will have a parent sign as trainer or coach and the parent must be a Competing Member.</li> <li>• Those competing without a trainer or coach will be required to sign the entry blank as the trainer/coach, therefore must have a Competing Membership. (<a href="#">GR404.4</a>)</li> </ul> <p>Show Passes are not required.</p> <ul style="list-style-type: none"> <li>• All participants in a USEF Lite competition agree to becoming a USEF Fan as a condition of participation in the competition (at no cost to the participant).</li> </ul>   |
| <b>Drug Fees and Federation Fees</b> | <ul style="list-style-type: none"> <li>• No fee collected (Regularly - \$23 - \$15 Drugs/Medications Fee &amp; \$8 Federation Fee)</li> <li>• All horses can be tested</li> <li>• Medication forms need to be filed electronically</li> <li>• With the exception of no fee collection, all rules in Chapter 4 apply</li> </ul>   |
| <b>USEF Safe Sport Requirements</b>  | <p>Non-Federation members, Competing Members under the age of eighteen (18), Subscriber members, and Fans are not required to complete the SafeSport Training.</p> <p>Exceptions - SafeSport Training is required for:</p> <ul style="list-style-type: none"> <li>• Any individual signing an entry blank as Trainer or Coach (including anyone competing without a trainer/coach), must have completed the SafeSport Training prior to the first day of competition.</li> <li>• Youth competing without a trainer or coach will have a parent sign as trainer or coach and the parent must be a competing member and have completed the SafeSport training</li> <li>• Competition Manager(s), Secretary, and any person acting in the role of a licensed official are bound by all requirements of the USEF Safe Sport Policy.</li> <li>• Any Competing Federation Member eighteen (18) years of age or older must have completed the SafeSport Training prior to the first day of competition.</li> </ul> <p>Participants in a Lite competition will be under the jurisdiction of the U.S. Center for SafeSport and will be subject to the U.S. Center of SafeSport Code and USEF Safe Sport Policy and afforded all related protections.</p>  |

| <b>Steward/TD</b>                              | <p>A person enrolled in pursuing a Federation Steward/TD license who has completed the Designated Applicant Training or a Federation Licensed Steward/TD.</p> <ul style="list-style-type: none"> <li>The Steward/TD does not need to be of the appropriate breed/discipline to officiate</li> </ul> <p>A Federation measurement card is not required for entry into height restricted classes at Lite Competitions.</p> <ul style="list-style-type: none"> <li>If a Lite Competition has hired a fully licensed Steward/TD with the applicable measurement certification, measurements may be performed at the competition for any exhibitors wishing to use the competition to obtain a Federation Measurement Card. <ul style="list-style-type: none"> <li>* Please note, applicant Stewards/TDs are not certified to measure.*</li> </ul> </li> </ul> <p>USEF Lite Organizer Grant:</p> <ul style="list-style-type: none"> <li>There is a <u>grant</u> program in place to assist competition organizers who choose to utilize an Applicant Steward or Applicant TD to officiate at their competition.</li> </ul> |
| <b>Judge</b>                                   | A Federation Licensed judge with appropriate card  |
| <b>License and Horse Fee</b>                   | <p>\$50 License Fee only</p> <p><i>*USEF has waived the application fee for the 2024 &amp; 2025 competition years*</i></p> <p>The \$1.50/horse fee is not collected (post comp report still needs to be submitted within ten (10) days of the competition's conclusion)</p>  |
| <b>Medical Personnel<br/>(See Chapter 8)</b>   | <p>Qualified medical personnel with no other duties and with appropriate medical equipment, as required by their certifying State or EMS Region, must be present during all scheduled performances at all competitions and during all paid scheduled schooling sessions over fences. An ambulance must be on the competition grounds or on call (on-call requires a contract with an ambulance service, calling 911 is not considered on-call) during all scheduled performances at all competitions and during all paid scheduled schooling sessions over fences.</p>   |
| <b>Mileage Boundaries</b>                      | Yes, fifty (50) radial miles   |
| <b>Results Ten Days After Show</b>             | <p>Yes; full results must be received by USEF within ten (10) days of the competition's completion.</p> <ul style="list-style-type: none"> <li>Full results include all exhibitors regardless of if they are USEF members or not</li> <li>USEF requires all owner and rider emails be included on the results</li> </ul>   |
| <b>HOTY Points</b>                             | <ul style="list-style-type: none"> <li>For HOTY points associated with the horse. Lite Competitions will award half- value points to all USEF Recorded horses, whose owner is a Federation Competing Member and meets any applicable breed/discipline required memberships.</li> <li>For HOTY points associated with the rider. Lite Competitions will award half- value points to all riders who are Federation Competing Members and meet any applicable breed/discipline required memberships.</li> </ul>   |
| <b>Post-show required documents</b>            | <ul style="list-style-type: none"> <li>Steward/TD Report</li> <li>Isolation Plan &amp; Accident Preparedness Plan</li> <li>Post Competition Report</li> <li>Results</li> </ul>   |
| <b>Prize List submitted to USEF for review</b> | <p>Prize Lists need to be submitted for review at least thirty (30) days prior to the start of competition and are required to include the statements listed under GR901.</p> <p>Exceptions:</p> <ul style="list-style-type: none"> <li>901.9 (bold statement regarding membership for participation)</li> <li>901.12 (Federation fee)</li> </ul> <p>Prize List Template available <a href="#">here</a></p>  |
